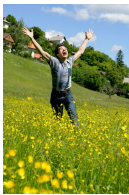

BACKGROUND

- Staff based within London and the M25 may have difficulties accessing their General Practitioners at times that suit them and/or their employers' needs. In some instances a standard 7 minute NHS appointment may mean a whole day of work lost. It makes good economic sense to make a private GP service readily accessible to staff – this can be accessed by them from 9am to 9pm weekdays at 1 Harley Street and 9-5 on Saturday's, or the doctor can visit them at their workplace.
- The Number One Health team led by Dr Charlie Easmon look after London-based expatriate staff for many international companies in the above capacity. This team is able to manage the same high-quality service for you.
- Dr Easmon will take medical responsibility for medico-legal issues relating to this service.

THE AGREED PROCESS TO ENSURE QUALITY OF SERVICE

- Staff will fill in a simple request/health form. This information will be forwarded to Number One Health.
- The individual will be seen by the Number One Health medical team who will:
 - Conduct a General Practice Consultation
 - Prescribe privately where necessary
 - Take blood tests where necessary
 - Conduct additional tests (i.e. Electro-cardiogram) where necessary
 - Refer to private specialists where necessary
 - Dictate a summary letter (1 copy for the individual, 1 for individual's GP)
 - Will give agreed vaccinations where necessary (i.e. flu, travel vaccines).

BILLING ARRANGEMENTS

Number One Health will send clients a pre-annual invoice covering:

- One Year's unlimited consultations plus paperwork at £140.00 per person per year
- Vaccinations according to attached prices
